#### Preamble:

Rev. Fr. Dr. Yeddanapalli was a pioneer scientist in Physical Chemistry who earned his Ph. D. and D. Sc. degrees from the Universities of Princeton, USA and Louvain, Belgium in late thirties. He was a contemporary of Albert Einstein at Princeton. He joined the Department of Chemistry, Loyola College, Madras in mid-forties and served as its Head from 1946 to 1970. He did valuable research in the areas of chemical kinetics, high polymers, chemisorption, heterogeneous catalysis, adsorption of polar gases on collagens and paper chromatographic studies of amino acids and proteins. He is considered as the founder and pioneer of catalysis research in India. Fr. Yeddanapalli served with great distinction and vision as Professor & Head for 25 years making significant contribution in imparting creative chemical education and initiating purposeful research programs that put Loyola College in the international map of scientific advancement. He was the founding member of the Catalysis Society of India and produced many illustrious catalyst scientists in India.

#### IMPORTANT INSTRUCTIONS TO NOMINATORS

Proposers may please ensure that the nomination form is duly completed and information as required by the Academy is sent ONLY as soft copies to ics.correspondence@gmail.com

- The Nomination is to be signed by the Fellow of Indian Chemical Society, or Fellow of any of the four National Academies or Head of Institute based personal knowledge of the scientific or professional attainments of the nominee. The nature of personal knowledge must be specified in the proforma; it could also be attached as a separate document on official letter head and appended to this nomination form at the end. Only a single file should be prepared and named as given before.
- The nominee must be a life member or life fellow, or student member depending on the category of the award. If the candidate is a non-member, a separate membership form must be submitted along with this nomination, otherwise it will be rejected. The office of the Indian Chemical Society will verify if the nominee is a member or not and ask for submitting application for membership.
- The current members of the Council of the Indian Chemical Society including office bearers are not eligible for any awards and should not be nominated.
- The nomination is to be sent duly completed in all respects by the Proposer to the office of the Indian Chemical Society by email so as to reach not later than the date mentioned by midnight. No hard copies are required.
- All entries in the nomination form should be completed. Nominations which are not complete in all
  respects and not accompanied by a List of Publications (including a list of up to ten most important
  publications). No correspondence thereafter will be entertained.
- A nomination will remain valid for consideration for 3 years. A renomination can only me made after waiting for a period of 2 calendar years.
- The last date is strictly followed. Nominations received by midnight on the last date of 31<sup>st</sup> July every year, will only be considered. Nominations will be open on 1<sup>st</sup> May every year.
- The decision of the Council of the Indian Chemical Society will be final, and no further correspondence be entertained.
- The President of the Indian Chemical Society will have the right of nominating deserving candidates who will enhance the prestige of the Award if a suitable nomination is not received.
- Not more than TWO nominations can be made by a fellow of ICS or other Academies. Only one nomination should be sent for any given award. However, Head of Institute can nominate up to 5 candidates for different awards.
