

Proceedings of a part of the 99th Annual General meeting of the Indian Chemical Society held virtually on Thursday, September 28, 2023 at 2.00 P.M.

The names of the Fellows and Members present in the Meeting are given in **Annexure - 1**.

At the outset, Professor Sudip K Das, the Honorary Secretary requested Professor G.D. Yadav, the President, to preside over the meeting. Professor Yadav took the chair and called the meeting to order. He welcomed the members present and sought the cooperation of the members and then requested the Honorary Secretary to take up the agenda items of the meeting. The Honorary Secretary conveyed his sincere thanks to the chair and welcomed the members present. He then placed the items of the agenda.

Proceedings

1. To confirm the Proceedings of the 98th Annual General Meeting of the Society held on December 30, 2022 in virtual mode.

The Honorary Secretary reported that the proceedings of the 98th Annual General Meeting of the Society held on December 30, 2023 had been duly circulated among the Fellows and Members of the Society and also uploaded on the website of the Indian Chemical Society and he did not receive any comments on the proceedings. Professor Pradeep K Sharma proposed that the proceedings of the 98th Annual General Meeting of the Society held on December 30, 2023 be accepted and Professor Akhilesh K Verma seconded the proposal of Professor Sharma. It was resolved that the proceedings of the 98th Annual General Meeting of the Society held on December 30, 2022 be confirmed.

2. To consider and adopt the Audited Statement of Accounts of different funds of the Society for the financial year 2022 - 2023.

3. To consider and adopt the Annual Report of the Society for the financial year 2022 – 2023. Note: The observation of the Council would be placed at the meeting.

The Honorary Secretary placed and read out the Annual Report of the Indian Chemical Society for the financial year 2022-2023. The Honorary Secretary also addressed all the queries of the members. During discussion Professor D C Mukherjee pointed out that the Indian Chemical Society had felicitated its past Presidents and Honorary Secretaries on May 09, 2023 at Kolkata in a befitting manner is inadvertently not included in the Annual Report. At this point, the President informed that those who were not available at Kolkata on May 09, 2023 will be felicitated at a subsequent program of the Indian Chemical Society.

After prolonged discussion Dr. Selvakumar Jayaprakasam proposed that the Annual Report of the Indian Chemical Society for the financial year 2022-2023 be accepted. The proposal of Dr. Jayaprakasam was seconded by Dr. Snigdha Ganguly.

It was resolved that the Annual Report of the Indian Chemical Society for the financial year 2022-2023 be accepted along with the inclusion of the points mentioned by the President and Professor D C Mukherjee.

4. To consider and adopt the Budget Estimate of the Society for the financial year 2024 – 2025. Note: The observation of the Council would be placed at the meeting.
